WHEREAS, this office is in receipt of your Application for grant of Consent to Establish for Hotel activities with Restaurants, lodging and Boarding for 120 Rooms for Lodging and Boarding u/s 25 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous & Other Waste (Management. and Trans boundary Movement) Rules, 2016 & Solid waste management Rules,2016.

AND WHEREAS, Board has issued Show Cause Notice vide above ref at Sr. No. (2) Following discrepancies: **a)** you have completed construction work of Hotel up to 4th floor without obtaining consent to Establish from MPC Board **b)** you are using Ground water through Bore well for Hotel construction activities, **c)** You have not uploaded copy of NOC from CGWA (Central Groundwater Authority).

AND WHEREAS, AND WHEREAS, you have not submitted /uploaded reply of show cause Notice issued by Board vide above ref. at Sr. No. (2).

AND WHEREAS, Your case was discussed in Consent Committee Meeting held on 04.10.2018 and 05.10.2018, As per minutes of CC Meeting dt. 04.10.2018 and 05.10.2018, Consent to Establish for Hotel activities is not approved and it was decided to issue final refusal of consent on following non compliances :

- (i) You have completed 4th floor construction work without obtaining Consent to establish.
- (ii) You have not submitted /uploaded NOC from CGWA as You are using ground water for Construction work.

AND WHEREAS, as you have fail to submit reply of show cause notice and compliance of same viz completion of 4th floor construction work without without obtaining consent to establish and NOC from CGWA, which shows your negligent attitude towards Environment Protection and compliance of consent conditions. As per Minutes of Consent Committee meeting of the Board held on 04/10/2018 and 05.10.2018, your consent application is here by refused.

In view of the aforesaid non compliances, your application for grant of consent to Operate for renewal is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
