We refer to the directions of closure issued by the Board vide letter dtd.01.08.2018 to **M/s. RMC Ready-mix (India)**, (A division of Prism Cement Ltd) C/o. Indo Nippon CTS no. 177, Cpme-13, LBS Marg, Ghatkopar West, Mumbai, Mumbai on the basis of the non-compliance observed during the visit of the officials of the Board along-with the representatives of NEERI to Ready Mix Concrete Plants located in Mumbai area from 06.07.2018 to 12.07.2018, wherein, you were directed to disconnect electricity / water supply to the aforesaid unit.

We refer to the order dated 19.09.2018 passed by the Hon'ble High Court, Mumbai in Writ Petitions bearing No. 3098 of 2018 & 3099/2018 wherein, the Hon'ble High Court directed to MPCB, to initiate fresh proceedings in accordance with law after issuing show cause notice to the petitioner.

In compliance of the Hon'ble High Court Order dtd.19.09.2018, the directions of closure issued by the Board vide letter dtd.01.08.2018 for disconnection of water/electricity supply are hereby withdrawn. You are, therefore, directed to restore electricity/water supply to **M/s. RMC Ready-mix (India)**, (A division of Prism Cement Ltd) C/o. Indo Nippon CTS no. 177, Cpme-13, LBS Marg, Ghatkopar West, Mumbai.
