Sub: Refusal of Consent and Authorization under Rule 10(2) of the Bio-Medical Waste Management Rules, 2016 and Environment (protection) Act, 1986.

WHEREAS, Ministry of Environment and Forests, Govt. of India in exercise of the powers conferred u/s. 6,8 & 25 of Environment (Protection) Act, 1986 has notified the Bio-Medical Waste Management Rules, 2016, and amended Rules, 2018, for proper management and handling of the Bio-medical Waste.

AND WHEREAS, it is the responsibility of common Bio-medical waste facility to treat & dispose off bio-medical waste at common facility in a scientific manner as per the provisions of the said Rules.

AND WHEREAS, this office has received your application from SRO, Kalyan – II for obtaining Consent to Establish for transportation of Bio-medical waste from Bhiwandi area.

AND WHEREAS, as per the minutes of 3rd cc – meeting held on 09.08.2019 it was noted that it will not be feasible for setting up of new BMWTDF facility at Bhiwandi. Since other authorized facilities exists within 75 kilometer radius.

AND WHEREAS, as per the policy of Board, grant of authorization only for Bio-medical waste transportation is not considered by Board.

AND THEREFORE, in view of the aforesaid reason, your application for authorization under the provisions of Bio-Medical Waste Management Rules, 2016 is hereby refused, which may please be noted.
