WHEREAS, the Maharashtra State has been declared as Water & Air Pollution Prevention Area under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981 respectively.


AND WHEREAS, it is mandatory on your part of any legal entity discharging sewage or trade effluent in the said area declared under the above said acts shall obtain prior consent from M.P.C. Board competent Authority as defined in the said notification. Also it is mandatory on part of occupier to comply with conditions stipulated in the consent order granted by the Board.

AND WHEREAS, it is obligatory on your part to provide necessary water & air pollution control devices and operate them efficiently and continuously so as to meet the standards prescribed in the Environment Protection Act, 1986. **AND WHEREAS**, it is also mandatory on your part to provide necessary collection, storage, treatment & disposal arrangements for the hazardous waste generated from your activities as per provisions laid down under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, this office is in receipt of processed application for grant of consent from Sub-Regional Officer, Tarapur-II referred above at sr. no. 1 reported non compliances of your industry and on this basis, this office has issued Show Cause Notice vide ref.2, from the record, it was noted that you have not submitted E.P.R. & relevant documents.

NOW THEREFORE, your application for grant of consent is hereby refused under section 27 of Water (Prevention & Control of Pollution) Act, 1974 & under section 21 of Air (Prevention & Control of Pollution) Act, 1981.

You may prefer an Appeal against refusal order passed by Maharashtra Pollution Control Board, in case aggrieved by the refusal order within a period of 30 days from the date of receipt of this refusal order.
