

WHEREAS, this office is in receipt of your application for grant of Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board office has issued show cause notice vide reference (2) above for non-submission of detailed manufacturing process, chemical reactions, material balance, non-installation of online monitoring system and non submission of statutory submissions.

AND WHEREAS, you have failed to submit reply to the show cause notice. Further, this office reminded you for submission of reply vide above reference (3). However, you have failed to reply to the SCN, despite of the sufficient and reasonable opportunity given for the submission of the same.

In view of above, your application for grant of Consent to Operate for is hereby **refused** under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
