3. CONDITIONS UNDER WATER ACT:

- The daily quantity of trade effluent from the factory shall not exceed Nil.
- The daily quantity of sewage effluent from the factory shall not exceed 0.4 M³.
- Trade Effluent : Nil
- Trade Effluent Disposal: Nil
- Sewage Effluent Treatment:** The applicant shall provide comprehensive treatment system as is warranted with reference to influent quality and operate and maintain the same continuously so as to achieve the quality of treated effluent to the following standards.
 - Suspended Solids Not to exceed 100 mg/l.
 - BOD 3 days 27o C. Not to exceed 100 mg/l.
- Sewage Effluent Disposal:** The treated domestic effluent shall be soaked in a soak pit, which shall be got cleaned periodically. Overflow, if any, shall be used on land for gardening / plantation only.
- Non-Hazardous Solid Wastes:** Nil
- Other Conditions:** Industry should monitor effluent quality regularly.
