WHEREAS, you have applied for grant of Renewal of Consent to Operate under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.


ANDWHEREAS, it is obligatory on your part to provide, operate and maintain Water and Air pollution control system properly.

ANDWHEREAS, vide reference (2) above, this office has issued SCN for Refusal of Consent for the non-compliances noticed such as: You are not operating ETP regularly. You have not provided the air pollution control system to the plating section. You have not obtained membership of CHWTSDf for the disposal of Hazardous Waste generated. As per existing consent condition, it was obligatory on your part to submit the Bank Guarantee of Rs.- 25,000/-, however till date, you have not submitted the same, Not replied to the scrutiny letter issued by SRO, Pimpri-Chinchwad.

ANDWHEREAS, you have not replied to the SCN issued by this office & also this office mail dated 24.07.2017.

ANDWHEREAS, it is noted that you have failed to address the above issues which shows your negligent attitude towards Environment Protections.

In view of above, **your application for grant of Renewal of Consent to Operate is hereby refused** under Section-27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section-21 of the Air (Prevention and Control of Pollution) Act, 1981.
