WHEREAS, you have applied for grant of Consent to Establish & Operate under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.


ANDWHEREAS, it is obligatory on your part to provide, operate and maintain Water and Air pollution control system properly.

ANDWHEREAS, vide reference (2) above, this office has issued SCN for Refusal of Consent for the non-compliances noticed such as: you have not provided Effluent treatment plant & Air pollution control system for plating section, not obtained membership of CHWTSDF for the disposal of Hazardous Waste generated. Also you have not obtained NOC from MCGM.

ANDWHEREAS, you have not replied to the SCN issued by this office vide letter dated 16.10.2017 till date.

ANDWHEREAS, it is noted that you have failed to address the above issues which shows your negligent attitude towards Environment Protections.

In view of above, your application for grant of Consent to Establish & Operate is hereby refused under Section-27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section-21 of the Air (Prevention and Control of Pollution) Act, 1981.
