
ANDWHEREAS, it is obligatory on your part to provide, operate and maintain Water and Air pollution control system properly.

ANDWHEREAS, you have not replied to the SCN issued by this office vide letter dated 23.12.2016 till date.

ANDWHEREAS, it is noted that you have failed to address the above issues which shows your negligent attitude towards Environment Protections.

In view of above, **your application for grant of Consent to Establish & Operate is hereby refused** under Section-27 of the Water (Prevention and Control of Pollution) Act, 1974 and under Section-21 of the Air (Prevention and Control of Pollution) Act, 1981.
