We refer to application for grant of Consent to Operate for renewal u/s 26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous Wastes & Other Waste (Management. and Transboundary Movement) Rules, 2016.

**AND WHEREAS** Board office has issued Show Cause Notice vide above ref at Sr. No (3), as **a)** you have not uploaded document related to change in name, **b)** You have not installed Air pollution Control system as per CREP Norms, **c)** You have not submitted Bank guarantees as previous consent conditions **d)** You have not installed online monitoring as per CPCB directions. **e)** you have not submitted NOC from CGWA, **f)** you have not paid additional consent fees of Rs.4,00,000/-

**AND WHEREAS**, Your Application for renewal of consent for 2500 TCD Sugar was discussed in Consent Committee meeting held on 23.03.2018 and 24.03.2018. As per minutes of CC meeting vide above ref at Sr. No. (4) , not approved renewal of Consent and decided to issue final refusal for renewal of consent as you have not uploaded document reg.change in name , You have not provided Air Pollution Control system as per consent condition, You have not submitted Bank guarantee as per BG regime, you have not obtained and submitted NOC from CGWA you have not installed online monitoring system as per CPCB directions. Not paid additional consent fees . ....2...

**AND WHEREAS**, you have not uploaded reply of show cause notice issued by Board vide above ref. at Sr. No. (3).

**AND WHEREAS**, as you have fail to submit reply of show cause notice and compliance of same viz not uploaded document reg change in name , not provided APC as per consent conditions, non-submission of Bank guarantee as per previous consent conditions , not provided online monitoring system as per directions issued by CPCB, not submitted NOC from CGWA, not aid additional consent fees , which shows your negligent attitude towards Environment Protection and compliance of consent conditions.

As per Minutes of Consent Committee meeting of the Board held on 23/03/2018 & 24/03.2018 your consent application is here by refused.

In view of the aforesaid non compliance, your application for grant of consent to Operate for renewal is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.
