WHEREAS, the Ministry of Environment and Forests, Govt. of India in exercise of the powers conferred by section 6,8 and 25 of the Environment (Protection) Act, 1986 has notified the Bio-Medical Waste Management Rules, 2016 for proper management and handling of the Bio-Medical Waste.

AND WHEREAS, you have made an application for grant of Consent to Operate under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 & the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Bio-Medical Wastes Management Rules, 2016.


AND WHEREAS, after scrutiny of your applications, it was observed that you have failed to submit required documents, which was brought to your notice vide email dtd. 16/09/2017 & reminder dtd. 04/10/2017. AND WHEREAS, due to non-submission of required documents, the MPC Board has issued show cause notice for refusal vide letter dated 14/11/2017.

AND WHEREAS, this office vide email on 09.11.2017 has given you an opportunity to submit the required documents within a stipulated period. Simultaneously, SCN for Refusal was also issued on 27.12.2017.

AND WHEREAS, despite of issuance of letter and show cause notice, you have failed to submit the required documents. AND WHEREAS, you have also failed to attend the scheduled personal hearing on 22.03.2017. This shows your negligence attitude towards the implementation of the Environmental Laws.

In view of the aforesaid non-compliance on your part, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 10(2) of the Bio-Medical Waste Management Rules, 2016.

If you are aggrieved with the said Refusal of Consent, you may prefer an Appeal under Section 28 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 31 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 16(1) of the Bio-Medical Waste Management Rules, 2016 before the Secretary, Environment Department, Govt. of Maharashtra, within a period of 30 days from the date of receipt of the said letter.
