WHEREAS, this office is in receipt of your application for grant of consent to renewal under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2016.

AND WHEREAS, Sub-Regional Officer, Raigad I has requested you to submit the requisite information vide letter cited at sr. no. (2) and you have failed to submit the satisfactory reply.

AND WHEREAS, the Board has issued show cause notice for refusal of consent vide letter cited at sr.no.(3). However, you have failed to submit the satisfactory information, despite sufficient reasonable opportunity given to you for the same.

AND WHEREAS, this office has considered your request vide your letter dtd 27.11.2017 & 22.12.2017 and kept the application in abeyance till date. Again you have submitted undertaking on 02.05.2018 wherein mentioned that, the installation of Dust control systems will be completed before 15.06.2018

AND WHERE, even after sufficient time given to you, you have failed to install equipments and machineries for your proposed activity.

In view of above, your application for grant of consent to renewal is hereby **refused** under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2016.
