Sub: Closure Directions u/s 33A of the Water (P&CP) Act, 1974 & u/s 31 A of the Air (P&CP) Act, 1981 r. w. Hazardous & Other Wastes (M&TM) Rules, 2016.

WHEREAS, you are operating the industry in the pollution prevention area declared under the Provisions of the Water (P&CP) Act, 1974 and the Air (P&CP) Act, 1981 and the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, it is obligatory on your part to obtain Conditional Combined Consent and Authorization to operate your industrial plant to discharge sewage and trade effluent in water pollution prevention area subject to certain terms and conditions more precisely under the provisions of 26 of the Water (P&CP) Act, 1974 and section 21 of the Air (P&CP) Act, 1981 and Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, it was also obligatory on your part to provide adequate and efficient pollution control devices and take adequate measures to control air & water pollution from all sources so as to achieve the standards prescribed in the Environment (Protection) Act 1986 and to disposed the Hazardous Waste to CHWTSDF.

AND WHEREAS, this office has received proposal from Sub-Regional Office, MPCB, Bhiwandi and reported following non- compliances.

- 1) You are Operating yarn sizing activity without obtaining consent from MPC Board.
- 2) You have not provided effluent treatment plant for trade effluent generating from sizing activity and untreated effluent is being directly discharged in to nearby nalla.
- 3) You have not provided air pollution control system like wet scrubber to coal fired boiler.
- 4) Your unit comes under MMRDA notified villages, which attract CC/OC from MMRDA. You have failed to produce same to the Board.

AND WHEREAS, after examining all the reports and records available with this office I have come to the conclusion that you are knowingly and willfully violating the provisions of the Water (P&CP) Act, 1974 and Air (P&CP) Act, 1981.

NOW THEREFORE, in exercise of powers conferred upon me by the Board u/s 33A of the Water (P&CP) Act, 1974 and u/s 31A of the Air (P&CP) Act, 1981. I, the Regional Officer, Kalyan hereby direct you to stop your manufacturing activity taking all precautionary measures for safe closure of the unit within 48 hours from receipt of this direction. It may also be noted that, the competent authorities are being directed to disconnect the electricity and water supply to your unit.
