- 2. You have failed to submit additional Consent fees from the period up to Jan. 2002.

3. You have failed to submit documents regarding change in name of your industry from M/s. Ronnel Chemicals Pvt. Ltd. to M/s. Siddhivinayak Chemicals.

AND WHEREAS, you have uploaded reply to the scrutiny letter vide under reference no. 5 on the web portal under the head scrutiny & show cause reply. However your reply is not in line with the Show Cause Notice. Also you have failed to submit additional Consent fees till date.
