Sub:-Refusal of Consent under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981.

WHEREAS, it is obligatory on your part to obtain the Consent to Establish/Operate under Section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and under Rule 5 of the Hazardous & Other Wastes (Management & Trans-Boundary Movement) Rules, 2016 from Maharashtra Pollution Control Board prior to establish any industrial activity and to comply with the conditions of said Consent. AND WHEREAS, it is also obligatory on your part to provide adequate pollution control systems and operate & maintain the same continuously and effectively so as to achieve the standards prescribed under Environment (Protection) Act, 1986 and to avoid any sort of pollution problem in the surrounding area.

AND WHEREAS, it is also obligatory on your part to comply with the provisions of the Maharashtra Plastic & Thermocol (Manufacture, Usage, Sale, Transport, Handling & Storage) Notification, 2018 & Plastic Waste Management Rules, 2016.

AND WHEREAS, this office has issued Show Cause Notice vide above reference for operating the unit without obtaining valid Consent from the Board, non-submission of the details regarding name and quantity of product with Code Number, buy back price on the bags, manufacturing process, NOC from concerned Grampanchayat for Plot No. 37, Gat No. 34, Ranjangaon, Tq. Gangapur, Dist: Aurangabad, EPR, not mentioning the cost of land and building premises in the undertaking and not obtaining the registration under the Plastic Waste Management Rules, 2016.

AND WHEREAS, after going through the reply submitted by you vide above reference (3), it is seen that you have mentioned as "Submitted the sample with printing", but not submitted the detail name and quantity of product with Code Number, buy back price on the bags and from the NOC submitted by you from Grampanchayat Ranjangaon (S.P.) dated 03/11/2018, it is seen that the said NOC is not for Plot No. 37, Gat No. 34, Ranjangaon, Tq. Gangapur, Dist: Aurangabad. As far as cost of land and building premises is concerned, you have mentioned that the premises is on rental basis, but you have not uploaded the rent agreement.

AND WHEREAS, you have failed to submit the detail name and quantity of product with Code Number, buy back price on the bags, correct NOC from concerned Grampanchayat for Plot No. 37, Gat No. 34, Ranjangaon, Tq. Gangapur, Dist: Aurangabad and detail rent agreement.

In view of above, your application for grant of Consent to Establish/Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981.
