WHEREAS, your unit is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under the Hazardous and Other Wastes (M & TM) Rules, 2016 followed by further amendments made therein from time to time. AND WHEREAS, it is obligatory on your part to obtain consent of the Board and to provide adequate air and water pollution control systems to control the pollution from your activity.

AND WHEREAS, you had applied for grant of consent vide above reference (1) and Sub-Regional Officer has processed and submitted the said application to this office with non-compliances as,


1. You have not uploaded Photographs of air pollution control system provided to control dust emissions from the activity such as, i) Details of Jaw Crusher/Screen/Conveyor belts/VSI/ transfer points covered by G.I. Sheets ii) Plantation provided along the periphery including nos. of tree planted and survived, area covered under tree plantation, life & height of the plants and trees species planted iii) Details of wind breaking wall, i.e. height, width length and details of wall i.e. RCC/Brick/Metallic iv) Metaled roads provided in the stone crusher premises with distance of roads in meters and width of roads in meters v) Dust suppression system i.e. water sprinkling and water fogging system provided in the area including no. of fixed water sprinklers and foggers provided and area in square meters covered vi) Details of mechanism adopted for regular cleaning and wetting of the ground/mechanical instruments provided and measures taken to control emissions during material handling i.e. loading, unloading, transportation etc.vii) Details of vehicles used for transportation with provisions made for covering of vehicles and provisions of dust suppression system provided at entry and exit gate.
2. You have not submitted source of water supply with details of water budget showing use of water for dust suppression and domestic purpose. If water source is from Bore Well/Dug Well, NOC obtained from CGWA is not uploaded.
3. You have not submitted material balance, i.e. Quantity of rubble stone used and quantity of finished products in the from of various sizes of stone metal and dust. Measures taken for stacking of raw material and finished products with area available in square meters.
4. You have not submitted source of raw material i.e. source of rubble stone and if mining activity is carried out in the same survey no. details of environmental clearance obtained for the activity, measures adopted to control fugitive emissions from the mining activity and blasting methodology adopted to avoid vibration in the area. Details of permission obtained for blasting activity.

5. Details of permission obtained from competent authority for extraction of Rubble stone from the Mine.

AND WHEREAS, Board has issued Show Cause notice vide above reference (3) under Clause B of Sub Section (4) of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 for refusal of consent and directed to submit your reply.

AND WHEREAS, it is noted that, after communication and given sufficient time period, you have failed to submit your satisfactory compliance and reply to above notices which shows your negligent attitude towards compliance of Provision of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Wastes(M&TM) Rules 2016.

In view of above, your application for Consent is hereby refused under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Waste 2016. Please note that operating of unit without valid consent of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
