WHEREAS, your unit is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under the Hazardous and Other Wastes (M & TM) Rules, 2016 followed by further amendments made therein from time to time.

AND WHEREAS, it is obligatory on your part to obtain consent of the Board and to provide adequate air and water pollution control systems to control the pollution from your activity.

AND WHEREAS, you had applied for grant of consent vide above reference (1) and Sub-Regional Officer has processed and submitted the said application to this office. After scrutiny non-compliances/discrepancies observed as,

1. Location plan /site map showing surrounding village/human habitation, town, river, road etc
2. Open space available and details of tree plantation. Details of no. of trees planted, area covered under green belt, species selected, height of plants, provisions made for watering to the plants with layout of piping network.
3. Certificate from competent authority about distance from river/creek (as per RRZ and CRZ policy). Distance certificate from competent authority showing crow fly distance of nearest village, roads from the location of stone crusher( Specify name of village with population, name of road/type of road i.e. Village road, ODR,MDR, State Highway, National Highway etc.
4. Detail layout plan of factory premises. Layout showing location of stone crusher unit, internal roads, wind breaking walls, Entry/Exit gate, Tree plantation area, adjacent area of the site etc. Area of land used for Stone Crusher, Details of N.A. permission obtained from competent authority.
5. Water budgeting showing water consumption for each process and effluent generation Include consumption and generation for domestic purpose. Source of water supply, provision made for storage of water for dust suppression with design layout, water used for dust suppression. If water source is from Bore well/Open Well, details of NOC obtained from CGWA for extraction of ground water.
6. Registered land lease agreement. Bank guarantee as per previous consent condition is not submitted.

AND WHEREAS, Board has issued Show Cause notice vide above reference (3) under Clause B of Sub Section (4) of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 for refusal of consent and directed to submit your reply.

AND WHEREAS, it is noted that, you have failed to submit the point wise reply/documents inspite of sufficient time period given to you, which shows your negligent attitude towards compliance of Provision of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Wastes(M& TM) Rules 2016.

In view of above, your application for Consent is hereby **refused** under Section 27 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Hazardous & Other Waste 2016. Please note that establishing the industry without valid consent of the Board is an offence and attracts further stringent legal action as deem fit under the provision of various Environmental enactments, which may please be noted.
