AND WHEREAS, you have submitted letter dt: 16/11/2018, in which you have submitted that you have placed an order for installation of wet scrubber as air pollution control system to Baggase fired Boiler & you have already purchased online monitoring system & erection & commissioning work is in progress.

AND WHEREAS, verification report submitted by SRO Nagpur-II office vide ref(4) reporting non compliances as under:

During visit ETP plant was not found in operation.

ii. Industry has not provided air pollution control system like ESP/dust collection system to Boiler stack.

Industry has not provided STP plant for treatment of domestic effluent iii. of tune 30 CMD,

iv. Leachate collection system not provided to molasses storage tank.

Online monitoring system not found in operation & also not connected v. to MPCB & CPCB sever (online monitoring system out of order).
