We refer to application for grant of Consent to operate (1st part) u/s 26 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981 and Hazardous & Other Waste (Management. and Transboundary Movement) Rules, 2016.

AND WHEREAS, your application was discussed in 6th Consent Committee Meeting dtd 03.10.2021 and accordingly Show Cause Notice was issued on 03.11.2019.

AND WHEREAS, considering your reply dtd 04.11.2019, your application was discussed in 8th consent Committee Meeting dtd 26.11.2019 and it was decided to grant 1st part consent to operate subject to payment of additional consent fees. Accordingly, Board has issued letter dtd 11.02.2020.

AND WHEREAS, the case was discussed in 15th Consent Committee meeting held on 20.03.2020 and it was decided to grant 1st part consent to operate after submission of additional consent fees for period upto 28.02.2021. **AND WHEREAS**, this was communicated to you vide Board office email vide ref(7) above and you have submitted your reply vide email dtd 14.09.2020.

AND WHEREAS, your application is reviewed in 10th CC meeting dtd 24.09.2020 and it was decided to keep the case in abeyance till payment of additional information. **AND WHEREAS**, it was noted that you have not paid additional consent fees till date.

AND WHEREAS, the case was discussed and reviewed in 5th Consent Committee meeting held on 25.06.2021 and it was decided to issue Show Cause Notice for refusal of consent for following non-compliance.

(i) You have not paid consent fee of Rs 125000/- for consent validity up to 28.02.2021. Further additional Rs 125000 consent fees is required for period upto 28.02.2022.

AND WHEREAS, you have not submitted your reply till date to the SCN issued on 18.05.2021.

AND WHEREAS, inspite of sufficient time given to you to comply with the SCN issued, you have not paid necessary consent fees and not complied with the SCN issued which shows your negligent attitude towards Environment Protection.

AND WHEREAS, the case was discussed in 8th Consent Committee meeting held on 11.09.2021 and it was decided to issue final refusal as you have not submitted reply to SCN issued on 18.05.2021.

In view of the aforesaid noncompliance, your application for consent to operate(part) is hereby refused under section 27 of the Water (Prevention and Control of Pollution) Act 1974 and under section 21 of the Air (Prevention and Control of Pollution) Act 1981.

You may prefer an appeal against the Refusal order passed by Maharashtra Pollution Control Board. Incase aggrieved by the refusal order, to the Appellate Authority i.e. Principal Secretary, Environment Department, Government of Maharashtra within thirty days of receipt of this of this order.
