

 This refers to the personal hearing extended to factory representative Regional Office MPCB, Chh.Sambhajinagar dtd-30/01/2024, during the personal hearing as agreed by your representative, it is directed to comply the following directions in time bond manner.

1. Industry is using coal instead of Briquette as given in consent, which shall be immediately stopped and shall use briquette as fuel.
2. Industry shall provide storm water drain within one month's period.
3. Industry shall dispose the Hazardous waste stored within eight days and submit manifest copy to Sub-Regional office MPCB Chh.Sambhajinagar.
4. Industry shall provide separate energy meter to MEE within eight days period.
5. Industry shall submit a time bound schedule towards provision of STP within eight days and shall complete the work of STP within three months period.
6. You shall submit fresh top-up Bank Guarantee of Rs.1.0 lakh, along with Original Bank Guarantee of Rs.2.0 lakh - at Regional Office MPCB Chh.Sambhajinagar towards the compliance of Interim Directions conditions.
7. Rs.50,000/- is forfeited from your existing Bank Guarantee of Rs.2.0 lakh towards non- Compliances of Boards Direction.

In case you fail to comply with the above directions, the Board will have no any option rather than to issue Closure Directions with disconnection of electricity and water supply of your unit, which may please be noted.
