WHEREAS, it is obligatory on your part to obtain Consent to Establish and Consent to Operate from the Maharashtra Pollution Control Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under the provisions of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016. It is also obligatory on your part to provide adequate pollution control devices.

AND WHEREAS, a complaint was received against your industry. In order to verify the complaint or news, the officials of the Board at SRO Mumbai-IV have visited the site at M/s Jay Laxmi Electroplaters, Gala No. 1, Azad Chawl, Hanuman Nagar, Near Kabrastan, Kandivali (E), Mumbai-400101 on 03.07.2024 and observed as follows:

- 1. You are engaged in manufacturing imitation jewelry with electroplating i.e. nickel, copper and acid cleaning.
- 2. Industry operating without consent to establish and operate.
- 3. You have not provided ETP for treatment of process effluent, untreated effluent discharged into sewage line.
- 4. You have not provided an adequate air pollution control system i.e. Scrubber.
- 5. You have not obtained membership of CHWTSDF for scientific disposal of Hazardous waste

AND WHEREAS, after examining the record of your case, the reports of the officers of the Board, it has been observed that you are operating your unit without obtaining consent from the Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 and adequate pollution control devices, thereby pollution in the surrounding area.

NOW THEREFORE, in view of the above non-compliances, you are hereby directed to stop your manufacturing activities forthwith, failing which, the Board will have no option than to initiate appropriate legal action under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981.
