**WHEREAS,** you are operating your industry in Water & Air Pollution Control area declared under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 respectively.

**AND WHEREAS,** Board has granted consent to operate under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 5 of the Hazardous & Other Wastes (M & T M) Rules 2016 & amendment 2019 is considered and the consent is hereby granted subject to the terms and conditions and as details in the schedule I, II, III & IV annexed there in.

**AND WHEREAS,** the News Published in daily Lokmat in respect of deteriorate a water quality of Ambazari Lake accordingly intensive survey carried out by officials and the Sub-Regional Officer, Nagpur-II submitted proposal through legal module for initiated legal action in respect of violation of consent conditions and discharge of untreated effluent outside premises is violations of consent conditions.

**AND WHEREAS,** this office had issued Show Cause Notice in respect of non-compliance of consent conditions, and directed to submit reply / compliance report within 07 days positively. AND WHEREAS, the reply and compliance if any not received to this office till date, is shows your negative attitude towards compliance of consent conditions / directions.

**AND WHEREAS,** you have fail to operate ETP round o'clock and it is under capacity, resulting untreated effluent discharge in local nalla. Also you have fail to provide flow meter at inlet and outlet of ETP as well as you have fail to maintain logbook of ETP Operation and disposal details of ETP Sludge and Used Oil.


**AND WHEREAS,** considering above non compliances it clear that, you are knowingly and willingly causing the grave injury to the Environment by creating air & water pollution in the nearby area.

**NOW, THEREFORE,** in exercise of the powers conferred upon the undersigned under section 33A of the Water (P&CP) Act, 1974 and under section 31A of the Air (P&CP) Act, 1981 I, hereby issue Proposed Directions against your industry as follows:

1. **Why your industry shall not be directed to stop the further manufacturing activities henceforth?**
2. **Why the competent authority shall not be directed to disconnect water/electricity supply to your unit?**

In view of above you are **directed to remain present in this Office for personal hearing on 25/10/2023 at 12.30 p.m. along with last one year water consumption bills** and your say / present status of your unit with relevant documents, failing which the Board will be constrained to issue appropriate final Directions as deemed fit in your case, which may please be noted.
