

This refers to the Show Cause Notice issued by Board and personal hearing extended to you on dtd. 18/07/2023. During the course of personal hearing, you were assured to comply with consent conditions. Further written submission made by you.

Non-compliances with respect to the consent conditions were discussed. Considering your assurance and submissions made during the course of hearing, following directions are issued for immediate compliances.

- 1) You shall Operate & Maintain Air Pollution Control System round O'clock to achieve consented standard.
- 2) You shall dispose Hazardous Waste regularly to CHWTSDf.
- 3) You shall extend and submit Bank Guarantee of Rs.50,000 & Rs.1,00,000/- within 7 days.
- 4) You shall submit Bank Guarantee of Rs.25,000/- within 7 days for forfeiture towards exceeding stack results.

In case of your failure to comply with the above directions, Board will proceed against you as per the provisions of the Water (P&CP) Act, 1974 and Air (P&CP) Act, 1981, Which may please be noted.
