With reference to fire incident occurred in M/s. Astec Lifesciences Ltd Plot No. K-2/1/2 Additional MIDC Mahad on 18.04.2024 and the compliance report submitted by SRO Mahad, personal hearing was extended to you on 14.05.2024 at head office.

During the course of personal hearing, you submitted DISH report and reported that necessary steps has been taken to control the fire incident, no injury /casualty happen in the incident. After due deliberation and assurance given by you following directions are issued for immediate compliance.

1. Industry shall comply the remarks raised by DISH department
2. Industry shall take necessary precautions/ utmost care to avoid such type of incident in future.
3. Industry shall dispose all burnt/unburnt residue or any other chemical contaminated material, and Hazardous Waste to CHWTSDF in a scientific manner under supervision of Department of Industrial Safety and Health and in coordination with authorities/representatives of Mumbai Waste Management, Taloja and local Police Administration on priority and submit the manifest copies to this office.

You are hereby directed to comply the above direction with immediate effect and submit the action taken report to this office within 7 days .In case ,you fail to comply with these directions, the Board will have no any other option any other than to proceed further legal action against you as per provision of Water (P & CP) Act, 1974 and Air (P & CP) Act, 1981, which may be noted.
