WHEREAS, you are operating your industry in Water & Air pollution prevention area declared under Water (P&CP) Act, 1974 Air (P&CP) Act, 1981. AND WHEREAS, it is obligatory on your part to obtain Consent to Establish / Operate from the Board under the provision of the Water (P & CP) Act, 1974 & the Air (P & CP) Act, 1981; to comply with conditions by providing necessary water & air pollution control devices and to operate the same continuously and efficiently so as to meet the standards prescribed by the Board at all times.

AND WHEREAS, Board has issued Show Cause Notice for closure on dtd. 09/01/2023 for following non compliances:

- 1) You have not provided barricading of height of 20 feet all around the periphery of the plot.
- 2) You have not provided water sprinkling / fogging system in the internal area as well as periphery of the plot for mitigation of dust.

3) You have not provided concreted internal work area.

4) You have not provided industrial vacuum cleaner for cleaning purpose.

5) You have not provided two level tyre washing facility.

6) You have not provided roof top Water sprinkling / fogging system for sand and aggregate / raw material storage area.

7) You have not provided sedimentation tank to collect waste water generated through washing activity.

8) You have not provided CAAQMS as per consent condition.

AND WHEREAS, personal hearing was also extended to you on 16/01/2023 and during the course of personal hearing, your representative agreed with not to operate the plant till all necessary compliances of SCN & RMC notification and permission from the Board.

NOW THEREFORE, in exercise of powers conferred upon me by the Board u/s. 33A of the Water (P&CP) Act, 1974 and u/s 31A of the Air (P&CP) Act, 1981, I, the Regional Officer, Thane hereby direct you not to operate the RMC plant till all necessary compliances of SCN & RMC notification and permission from the Board are obtained. Nevertheless, the electricity shall not be disconnected in order to carry out repairing and compliance of above points, however you shall submit Bank Guarantee of Rs. 1.0 Lakh towards not to operate the RMC plant till obtaining permission from the Board.

In case of your failure to comply these directions, further suitable action which may be deem fit, as per the provisions of the Environmental Act's will be initiated against your unit, which may please be noted.
