**WHEREAS**, it is mandatory and obligatory on your part to obtain Consent from the Maharashtra Pollution Control Board under Section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Waste (Management & Transboundary Movement) Rules, 2016 for running the industrial activity at aforesaid location.

**ANDWHEREAS**, Hon'ble National Green Tribunal, Principal Bench, New Delhi in the application no.37/2013 filed by Wassan Singh Vs. State of Punjab have passed the order no. 4 that SPCB shall seal the unit those are in operation without obtaining Consent from State Pollution Control Board (SPCB) vide above reference **cited at 1.**



**WHEREAS**, Hon'ble Supreme Court of India have passed order for closure of the industries those are in operation without providing / operating the effluent treatment plant for the treatment of effluent generated from the industry and without obtaining proper Consent from State Pollution Control Board in the Writ Petition (Civil ) No. 375/2012 dtd. 22.02.2017 vide above reference cited at 2.

**WHEREAS**, the Board has published notice in the newspaper regarding the said order passed by Hon'ble Supreme Court of India vide above reference cited at 3.

**WHEREAS**, the Hon'ble NGT has issued order on 19.9.2019 in OA No. 400 of 2019 filed by Social Action for Forest and Environment (SAFE) Vs Union of India and Others.

**WHEREAS**, Board official visited to your industry on 02.06.2022 for investigation of complaint and checking the point wise compliance as per MoEF & CC SOP the Office Memorandum issued by MoEF & CC , Govt of India dtd 24/11/2015 for tyre pyrolysis units.

**ANDWHEREAS**, Complaint received from Mr. Akash Waykar on 02.06.2022 regarding Air pollution, vide above reference cited at 6.

**ANDWHEREAS**, Board official from SRO Ahmednagar office visited your unit on and submitted proposal to this office recommending for stringent action against the industry due to following non compliances.

1. The industry is in operation without obtaining consent to operate from the Board from last one year.
2. The industry has not provided ETP plant, waste water (Blackish color) stored in kattcha pit.
3. The industry has not provided scrubber to the reactor.
4. The industry feeding waste tyre in the reactor manually.
5. The industry has not provided Nitrogen cylinder for purging in the reactor.
6. The industry has not provided proper storage facility to carbon black, waste tyre.

**ANDWHEREAS**, after examining the record of your case and after making necessary enquiry this office has concluded that you have violated the provisions made under various environmental enactments as well as causing pollution problem in the nearby surrounding area knowingly and wilfully.

**NOW THEREFORE**, in exercise of the powers confirmed upon me by the Board, I Dr.P.M Joshi, Regional Officer of the Board at Nashik hereby directed you to stop your production activity forthwith till further directions/order of the Board in a safe manner and the competent authorities are hereby also directed to disconnect electricity and water supply of your industry immediately, which may be noted.



This is issued with the post facto approval of the competent authority of the Board.
