Considering your assurances to improve Environment in your Unit, following Interim directions are issued under Section 33A of the Water (P & CP) Act, 1974 & 31A of the Air (P&CP) Act, 1981 for compliance.

- 1. You shall apply for consent to establish and operate immediately.
- 2. You shall provide organic waste converter,
- 3. You shall provide air pollution control system to D.G. Set (125 KVA)
- 4. You shall provide Sewage Treatment Plant for Domestic Effluent Generation.
- 5. You shall follow Circular dtd 24.11.2016 and CPCB guidelines dtd 19.09.2019for of Hotels / Motels in toto.
- 6. You shall submit Bank Guarantee of Rs. 50,000/- towards compliance of above points in favor of Regional Office, M.P.C. Board, Nagpur within 15 days.

In case, you fail to comply with the above Directions, the Board will have no option than to forfeit the Bank Guarantee and issue final directions as deemed fit in your case, along with suitable legal action which may please be noted.
