

This refer to above reference no. (3) Proposed Direction issued to your unit on 25.11.2024. Personal Hearing is extended to factory representative, During the personal hearing as agreed by your representative, it is directed to comply with the following directions in time bound manner:-

1. You shall carry out the maintenance of effluent transfer pump provided to collection tank immediately. Further you shall make arrangement of standby pump and shall ensure that no untreated waste water is disposed on land.
2. You shall maintenance of scrubbing pump provided to plating section immediately.
3. You shall make provision of storage of treated waste water in a dedicated tank of 10,000 liter capacity and primary treated waste water shall be sent to CETP waluj with immediate effect.
4. You shall dispose Hazardous waste to Common Hazardous waste Disposal facility regularly by following manifest system.
5. The Bank Guarantee of Rs. 25,000/- stands forfeited and fresh Bank Guarantee of Rs. 50,000/- shall be submitted to this office within 15 days.

In case, you fail to comply with the above directions, the Board will have no any option rather to issue Closure Directions with disconnection of electricity and water supply of your unit, which may please be noted.
