**WHEREAS**, you are operating your industry in Water & Air pollution prevention area declared under Water (P&CP) Act, 1974 Air (P&CP) Act, 1981. **AND WHEREAS**, Board has granted consent to your industry subject to certain terms & conditions therein. **AND WHEREAS**, it is obligatory on your part to comply those conditions and provide necessary water & air pollution control devices and operate them continuously and efficiently so as to meet the standards prescribed by the Board at all times.

**AND WHEREAS**, Board has issued Show Cause Notice for closure on dtd. 02/06/2022 based on following non compliances reported by Survey team during their visit to your unit on dtd. 01/06/2022 as,

- 1) You have not provided dust containment cum suppression system to jaw crusher, vibratory screen & belt conveyor.
- 2) You have not provided water sprinkling arrangement to belt conveyors and finished product discharge points. Also, water sprinkling arrangement not provided within the premises for dust suppression.
- 3) You have not provided wind breaking wall.
- 4) You have not provided metallic Road within the premises.
- 5) You have not carried out tree plantation along the plot.

**AND WHEREAS**, during course of personal hearing dtd. 14/06/2022 your representative agreed with non compliances reported by Board officials during their visit thus you have failed to comply with Show Cause Notice for closure issued dtd. 02/06/2022.

**AND WHEREAS**, after examining all the reports and records available with this office, I have come to the conclusion that you are knowingly and willfully violating the consent conditions under the provisions of Water (P & CP) Act, 1974 and Air (P & CP) Act, 1981.

**AND NOW THEREFORE**, in the exercise of the powers conferred u/s 33A of Water (Prevention & Control of Pollution) Act 1974, and 31A of Air (Prevention & Control of Pollution) Act, 1981. I, Regional Officer, MPCB, Thane hereby directed to close down your manufacturing activities immediately taking all precautionary measures, It shall be noted that competent authorities are hereby directed to disconnect your electricity and water supply.

In case of your failure to comply these directions, further suitable action which may be deemed fit, as per the provisions of the Environmental Act's will be initiated against your unit, which may please be noted.
