ANDWHEREAS, this office has issued Show Cause Notice on 09.02.2021, for not operating Sewage Treatment Plant, Effluent Treatment Plant and for using ground water without obtaining NOC from CGWA, vide above reference cited at 4.

ANDWHEREAS, after examining the record of your case and after making necessary enquiry this office has concluded that you are not complying with the consent conditions and violated the provisions made under various environmental enactments as well as causing pollution problem in the nearby surrounding area knowingly and wilfully.

NOW THEREFORE, in exercise of the powers confirmed upon me by the Board, I Dr.P.M Joshi, Regional Officer of the Board at Nashik hereby directed you to stop your production activity forthwith till further directions/order of the Board in a safe manner and the competent authorities are hereby also directed to disconnect electricity and water supply of your industry immediately, which may be noted.
