Sub: Closure directions u/s 33A of the Water (P&CP) Act, 1974 and u/s 31 A of the Air (P&CP) Act, 1981 read with Plastic Waste Management Rules, 2018.

WHEREAS, it is obligatory on your part to obtain Consent of the Maharashtra Pollution Control Board under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981

AND WHEREAS, the Environment Department, Government of Maharashtra has issued a Public Notice in Daily Newspaper in the State of Maharashtra on 02/01/2018 in respect of restriction in Maharashtra State on use of products made of plastic and thermocol for the information of the general public as well as all concerned engaged in manufacturing, selling, distribution and/or storing of products of plastic and thermocol. Maharashtra State has restricted the use of variety of plastic products like dishes, plates, cups, bowls, glasses, vases, forks, spoons, flexes, non-woven polypropylene bags, banners, festoons, flags, plastic sheets and all types of plastic covers etc.

AND WHEREAS, the Environment Department, Government of Maharashtra has published the Notification No. Plastic-2018/C.R.No.24/TC-4, dated 23/03/2018, for banning in the whole State of Maharashtra on manufacture, usage, transport, distribution, wholesale & retail, sale & storage, import of the plastic bags with handle and without handle and the disposable products manufactured from plastic and thermocol into the market (polystyrene) such as single use disposable dishes, cups, plates, glasses, fork, bowl, container, disposable dish / bowls used for packaging food in hotels, spoon, straw, non-woven polypropylene bags, cups / pouches to store liquid, packaging with plastic to wrap or store the products, packaging of food items and food grain material etc.


AND WHEREAS, it is mandatory on your part to comply with the Notification dtd.23/3/2018 issued by the Government of Maharashtra.

AND WHEREAS, This office has received proposal from Sub-Regional Office, MPCB, Bhiwandi reporting following non- compliances.

1. You are manufacturing plastic products which is banned under Maharashtra Plastic and Thermocol Products (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification Dated 23/3/2018.
2. You are operating your industry without valid consent from Board.
3. You have not obtained the registration under The Plastic Waste Management Rules, 2016.

AND WHEREAS, after examining all the reports and records available with this office I have come to the conclusion that you are knowingly and willfully violating the provisions of the Water (P&CP) Act, 1974 and Air (P&CP) Act, 1981.

NOW THEREFORE, in exercise of powers conferred upon me by the Board u/s 33A of the Water (P&CP) Act, 1974 and u/s 31A of the Air (P&CP) Act, 1981. I, the Regional Officer, Kalyan hereby direct you to stop your manufacturing activity with immediate effect from receipt of this direction. It may also be noted that, the competent authorities are being directed to disconnect the electricity and water supply to your unit.
