WHEREAS, you have been granted consent to operate under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 31(A) of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 6 of the Hazardous & Other Wastes (M & T M) Rules 2016 & related amendments made therein is applicable to the state of Maharashtra as declared in official gazette.

AND WHEREAS, Board office has received hunger strike letter from Mr. Mudassir Ahmed Patel, Founder, and president of Chhava Maratha Yodhha and Mr. A. Vahab Musa Matvankar, Shakhapramukh, Shivsena. Also received Complainants from Hon'ble MLA Mr. Bharatshet Gogavale to Hon'ble Environment Minister. Also, letter received from Sarpanch, Group Grampanchayat Tol Budruk, regarding cancellation of NOC to crusher. Board official of SRO Mahad visited to your unit on 04.04.2022 reported following noncompliance's;

1. You have not provided Wind breaking wall.
2. You have not provided Metal road within premises.
3. You have not provided water sprinkling arrangement.
4. You have not provided adequate APC system.
5. You have not fulfilling the distance criteria at S. No. 341, Tol Budruk & it is about 65 mtr from Tol Nandavi Road(Z.P. road). As per the distance criteria it requires distance 100 mtr from other district road.


AND WHEREAS, Board had issue Proposed Direction dtd. 07.04.2022 but you have failed to comply for the same, this shows your negligent attitude towards Environment.

AND WHEREAS, Personal hearing extended to you on 11.05.2022 befor Regional Officer, Raigad. Where in you have agreed that location of your industry does not satisfy the distance criteria as per the Board's circular.

AND WHEREAS, after examining the records of your case, the reports of the Officers of the Board and after making necessary enquiries, I have observed that, you have violated the consent conditions and provision of various Environmental Acts. This shows your negligent attitude toward Environment Protection and causing grave injury to the surrounding environment knowingly and willfully.

NOW, THEREFORE, in exercise of the powers conferred upon me under Section 33A of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 31A of the Air (Prevention & Control of Pollution) Act, 1981, **I, the undersigned hereby direct you to close down your manufacturing activities within 72 hours**, so as avoid further damage to the surrounding environment and inform the same to this office immediately. The competent authorities are directed to disconnect the water/electricity supply to your unit, which may be noted.
