

This refers to Proposed Directions issued by the Board vide above reference at 1 & legal action proposal submitted by SRO Kolhapur vide above reference cited at 2.

The personal hearing of industry representative was extended on 10.03.2025 & as agreed by the industry representative during Personal Hearing, it is directed to comply with following directions:-

1. Industry shall provide water sprinkling arrangement at jaw crusher, conveyor belts & transfer point up to March end.
2. Jaw crusher, conveyor belts, screen, VS, material transfer point all should be covered by GI/MS Sheets up to March end.
3. Water sprinkling arrangement on road & stone crusher premises should be carried out frequently to avoid fugitive dust emission up to March end.
4. Compound wall of 20 feet height along the periphery of stone crusher should be provided within 45 days.
5. Industry shall submit bank guarantee of Rs. 50000/- towards above non-compliance within 7 days in favor of Regional Officer, Maharashtra Pollution Control Board, Kolhapur.

In case of failure of above directions, the Board will have no any other option to issue final directions as may deem fit in your case, which may be noted.
