- 1. Heavy dust emission accumulated and fugitive dust emission observed due to plying of vehicles, water sprinkling not observed in premises.
- Two level tyre washing not provided due to which dust ladden vehicles ply on road, regular cleaning and wetting of premises not done.
- Records of debris disposal are not produced & Debris/C&D waste found stacked in heaps in premises and M/s. Runwal site and not covered with tarpaulin.
- 4. You have not provided Mobile foggers & Industrial vacuum cleaner.

NOW THEREFORE, in view of the aforesaid non-compliances, following direction are issued against your unit as to –

- 1. Why your consent shall not be revoked?
- 2. Why your industrial activities shall not be closed down ?
- 3. Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit ?
