**Sub:** Proposed Directions under section 33 A of Water (Prevention & Control of Pollution) Act, 1974 **and** under section 31A of Air (Prevention & Control of Pollution) Act, 1981.

**WHEREAS**, the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 on 28.11.2022, which was valid upto 28.02.2026, subject to certain terms and conditions.

**AND WHEREAS**, it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions so to achieve the standards prescribed by Board in its consent.

**AND WHEREAS**, in order to, the officials of the Board visited the site in question on 05.09.203 & 12.09.2023 and observed as follows:-

1. You have not provided ZLD as per Consent condition.
2. You have provided flow meter at inlet n outlet of ETP /STP provided whereas flow meter at ETP inlet is not in working condition.
3. You have not provided Separate energy meter to ETP.
4. You have provided filters to ETP not found in operation.
5. You have not maintained the housekeeping nearby effluent treatment plant.
6. You have stored effluent treatment plant sludge, whereas sludge was observed on surface of Intermittent tank, aeration tank & in final treated tank.


7. You are using mixed industrial & domestic effluent to gardening purpose, whereas industrial effluent shall be disposed to CETP as per consent condition.
8. You have provided fume extraction system followed by scrubber and chimney for salt bath furnace, which was out of order, ducting was badly corroded and broken, no hood at place, the scrubber was not in working condition, the chimney was highly corroded and in unsafe conditions.
9. You have not provided Air pollution Control system to salt bath furnace.
10. You have not upgraded the fume extraction system, scrubber & APCS along with ducting, hood & stack as per consent condition.
11. During visit oil contaminated seepages observed near grinding bur storage section.
12. You have not provided dedicated environment cell for operation & maintains of Effluent treatment plant.
13. You have not maintained the inspection book.

**AND WHEREAS** it has been observed that you have failed comply with the conditions stipulated in Consent granted by the Board and thereby discharging effluent into the environment .AND Whereas, discharging air emissions without adequate APCS into the environment & thereby causing water & air pollution.

**NOW THEREFORE**, in view of the above non-compliance, you are hereby directed to show cause as to:

1. Why your consent shall not be refused / revoked?
2. Why your industrial activities shall not be closed down?
3. Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit ?

You are hereby given an opportunity to respond within 7 days from issuance of these directions, failing which, MPCB will initiate legal action against your unit without giving any further notice in accordance with the provisions of the Water (prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981, which please note.
