Sub : Proposed Directions under Section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.

WHEREAS, you are operating your industry in Water & Air Pollution Control area declared under the provisions of Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 respectively.

AND WHEREA, Board has granted consent to operate under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 5 of the Hazardous & Other Wastes (M & T M) Rules 2016 & amendment 2019 is considered and the consent is hereby granted subject to the terms and conditions and as detailed in the schedule I, II ,III & IV annexed there in.

AND WHEREAS, Officials visited to your unit for checking compliance of consent condition and Restart Direction issued as per ref. no. 1. **AND WHEREAS,** Sub-Regional Officer, Nagpur-II has submitted proposal towards violations consent conditions as under:-

- 1) You have fail to Operate ETP round O'clock and fail to disposed trade effluent to CETP which is generated in turn of 20 CMD is shows that discharge of effluent outside factory premises.
- 2) You have fail to provide biofilter to rendering plant as well as not provided deodorant sprinkling arrangement around the periphery of the unit.
- 3) You have fail to provide scientific storage and disposal arrangement of organic solid waste, resulting foul causing around the area.
- 4) You have fail to provide dust collection system at poultry exhaust, resulting dust emissions letting out in atmosphere as well as causing smell nuisances.

- 5) You have discharge boiler blow down effluent having pH 10 on open ground.
- 6) You have fail to maintain record about disposal of died birds as well as not provided scientific arrangement for its disposal.
- 7) You have fail to provide flow meter at ETP inlet and outlet.
- 8) You have fail to provide STP for treatment of domestic effluent resulting discharge of effluent outside factory premises.

AND WHEREAS, considering above non compliances it clear that, you are knowingly and willingly causing the grave injury to the Environment by creating air & water pollution in the nearby area.

NOW, THEREFORE, in exercise of the powers conferred upon the undersigned under section 33A of the Water (P&CP) Act, 1974 and under section 31A of the Air (P&CP) Act, 1981 I, hereby issue Proposed Directions against your industry as follows:

1. **Why your industry shall not be directed to stop the further manufacturing activities henceforth?**
2. **Why the competent authority shall not be directed to disconnect water/electricity supply to your unit? or forfeit suitable amount of Bank Guarantee.**

You shall submit your reply/objections within a period of 07 days from the date of receipt of these directions, failing which the Board will be constrained to issue appropriate final directions, as may deem fit in your case, which may be noted.
