WHEREAS, the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under Rule 6 of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016.

AND WHEREAS, it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions to achieve the standards prescribed by the Board in consent.

AND WHEREAS, The M.P.C. Board official has visited your industry on 02/07/2024 for checking of compliance of consent conditions. Accordingly, Sub Regional Officer Nagpur-II has submitted proposal through legal module with mentioning non compliances i.e.

1. You have fail to operate and maintain ETP round O'clock, resulting effluent having pH 10 found stagnant in the premises of ETP

2. You have fail to operate coil evaporations system, provided as maintaining Zero Liquid Discharge (ZLD).

3. You have fail to sufficient capacity of wet scrubber to Furnace Oil fire baby boiler resulting blackish carbon particles found settled on ETP and boiler area.

4. You have fail to provide proper arrangement for storage of Furnace Oil resulting oil found spared around the storage area as well as leakages were found at furnace oil carrying pipe line.

AND WHEREAS, it seems that, you are knowingly and willingly causing the grave injury to the Environment by creating pollution in the nearby area.

NOW THEREFORE, considering the above non-compliance, you are hereby directed to show cause as to:

1) Why your industrial activities shall not be closed down forthwith?

2) Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit?

You are hereby given an opportunity to respond within 07 days from issuance of these directions and directed to remain present in this office for a personal hearing on 24 07 2024 at 3-00 p.m. along with all necessary documents and compliance report. failing which, MPCB will initiate legal action against your unit without giving any further notice in accordance with the provisions of the Water (prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.
