WHEREAS, the Maharashtra Pollution Control Board has granted you Combined Consent under the provisions of the Water (P&CP) Act, 1974 and the Air (P&CP) Act, 1981 and Authorization under the provisions of the Hazardous & Other Wastes (Management & Trans boundary Movement) Rules, 2016, subject to certain terms & conditions.

AND WHEREAS, it was obligatory on your part to provide adequate and suitable pollution treatment & disposal arrangements, so as to achieve the standards prescribed in the consent and to dispose of it in accordance with the condition laid down for disposal in the consent.

AND WHEREAS, this office has received proposal from Sub-Regional Office, MPCB, Bhiwandi and reported that as below. During visit Board officials observed that you are using unconsented fuel i.e. Biomass Briquette in coal fire Boiler.

NOW THEREFORE, in view of afore said facts, you are hereby directed to Show Cause as to why legal action should not be initiated against you under the provisions of Water (P & CP) Act, 1974 & Air (P & CP) Act, 1981.

Your reply shall reach this office within period of 03 days from date of receipt of this direction, you are hereby called upon to remain present for **personal hearing on 24/06/2022 at 11:50 a.m.** along with relevant documents/ reply failing which, the Board will have no option then to initiate appropriate legal action against you, which please note.
