**WHEREAS**, you are operating the industry in the pollution prevention area declared under the Provisions of the Water (P&CP) Act, 1974 and the Air (P&CP) Act, 1981 and the Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016.

**AND WHEREAS**, it is obligatory on your part to obtain Conditional Combined Consent and Authorization to operate your industrial plant to discharge sewage and trade effluent in water pollution prevention area subject to certain terms and conditions more precisely under the provisions of 25/26 of the Water (P&CP) Act, 1974 and section 21 of the Air (P&CP) Act, 1981 and the Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016. **AND WHEREAS**, it was also obligatory on your part to provide adequate and efficient pollution control devices and take adequate measures to control air & water pollution from all sources so as to achieve the standards prescribed in the Environment (Protection) Act 1986.

**AND WHEREAS**, this office has issued closure direction vide reference no. 2 above violations of consent conditions and directions issued from time to time.

**AND WHEREAS**, this office has received proposal for action from Sub-Regional Office, Kalyan-III mentioning following non compliances:

- 1) MLSS concentration in the Bioreactor found very less.
- 2) Analysis result of ETP outlet found exceeding consented standards for the parameter BOD-150 mg/l and COD- 416 mg/l.
- 3) You have not provided Zero Liquid Discharge as per the consent condition.
- 4) You are disposing treated effluent on land for gardening.
- 5) You have not obtained NOC from CGWA for extraction of ground water.
- 6) You have not provided scientific composting system for treatment of wet garbage such as Potato peels, Banana peels etc. thereby causing nuisance to nearby area.

**AND WHEREAS**, after examining all the reports and records available with this office I have come to the conclusion that you are knowingly and willfully violating the provisions of the Water (P&CP) Act, 1974 and Air (P&CP) Act, 1981.

**NOW THEREFORE**, in exercise of powers conferred upon me by the Board u/s. 33A of the Water (P&CP) Act, 1974 and u/s 31A of the Air (P&CP) Act, 1981. I, the Regional Officer, Kalyan hereby direct you to stop your manufacturing activity taking all precautionary measures for safe closure of the unit within 48 hours from receipt of this direction. It may also be noted that, the competent authorities are being directed to disconnect the electricity and water supply to your unit.
