WHEREAS, the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under Rule 6 of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016,.

AND WHEREAS, it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions so as to achieve the standards prescribed by the Board in its consent.

AND WHEREAS, the Board has received a complaint regarding discharge of effluent from industries located in STICE, Musalgaon.

AND WHEREAS, in order to verify the complaint received vide referred above No.2 the officials of the Board at Nashik visited the site vide referred above No.3 in question and observed as follows:-

1. It is noticed that dust is observed deposited over the ETP Structure, initial or primary washing of cylinder take place on open ground (which is not RCC) and washed effluent find its way to downstream,
2. Not having the adequate storage and handling facility for hazardous waste.
3. Dust collector & water curtain are provided but same are not operating at full efficiency and the dust and paint disposal spray observed outside on wall as well as land Near the ETP area,
4. Sewage Treatment Plant (STP) not provided, oily waste of existing furnace oil storage area yet not disposed.


AND WHEREAS it has been observed that you have failed to comply with the conditions stipulated in the Consent granted by the Board and thereby creating the smell nuisance into the environment and nearby area and thereby causing air pollution into the environment.

NOW THEREFORE, in view of the above non-compliance, you are hereby directed to show cause as to:

1. Why your consent shall not be refused?
2. Why your industrial activities shall not be closed down ?
3. Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit ?

You are hereby called upon for personnel hearing **on 26.09.2024 at 3.00 P.M** before undersigned at above address, failing which, MPCB will initiate legal action against your unit without giving any further notice in accordance with the provisions of the Air (Prevention & Control of Pollution) Act, 1981, which please note.
