WHEREAS, it is mandatory and obligatory on your part to obtain Consent from the Maharashtra Pollution Control Board under Section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Hazardous Waste (Management & Transboundary Movement) Rules, 2016 for running the industrial activity at aforesaid location.

ANDWHEREAS, Hon'ble National Green Tribunal, Principal Bench, New Delhi in the application no.37/2013 filed by Wassan Singh Vs. State of Punjab have passed the order no. 4 that SPCB shall seal the unit those are in operation without obtaining Consent from State Pollution Control Board (SPCB) vide above reference **cited at 1.**

WHEREAS, Hon'ble Supreme Court of India have passed order for closure of the industries those are in operation without providing / operating the effluent treatment plant for the treatment of effluent generated from the industry and without obtaining proper Consent from State Pollution Control Board in the Writ Petition (Civil) No. 375/2012 dtd. 22.02.2017 vide above reference **cited at 2.**

ANDWHEREAS, the Board has published notice in the newspaper regarding the said order passed by Hon'ble Supreme Court of India vide above reference **cited at 3.**

ANDWHEREAS, Complaint received from Shri. Ramesh Jete on 10.03.2022, vide above reference cited at 4.

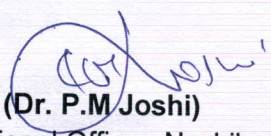
ANDWHEREAS, Board official from SRO Ahmednagar office visited your unit on 15.03.2022, vide above reference cited at 5. and submitted proposal to this office recommending for stringent action against the industry due to following non compliances.

1. The industry is in operation without obtaining consent to operate from the Board.
2. The industry has not provided surrounding wall around the crusher.
3. The industry has not covered loading & unloading section with G. I. Sheet, fugitive emission observed during visit from loading section & unloading section.
4. The industry has not provided display board at entrance of the Stone Crusher.
5. The industry has not provided Fogging system arrangement for wetting of road within premises.
6. The industry has not covered Conveyor Belts with GI sheet.
7. The industry has not provided wind breaking wall.
8. The industry has not covered Vibrating screen.

ANDWHEREAS, after examining the record of your case and after making necessary enquiry this office has concluded that you have violated the provisions made under various environmental enactments as well as causing pollution problem in the nearby surrounding area knowingly and wilfully.

NOW THEREFORE, in exercise of the powers confirmed upon me by the Board, I Dr.P.M Joshi, Regional Officer of the Board at Nashik hereby directed you to stop your production activity forthwith till further directions/order of the Board in a safe manner and the competent authorities are hereby also directed to disconnect electricity and water supply of your industry immediately, which may be noted.

This is issued with the post facto approval of the competent authority of the Board.
