**WHEREAS**, the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under Rule 6 of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016, (CCA) on 30.12.2022 which is valid upto 30.11.2032 subject to certain terms and conditions.

**AND WHEREAS**, it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions so as to achieve the standards prescribed by the Board in its consent.

**AND WHEREAS**, the Board has received a complaint regarding discharge of effluent from industries located in STICE, Musalgaon.

**AND WHEREAS**, in order to verify the complaint received vide referred above No.2 the officials of the Board at Nashik visited the site vide referred above No.3 in question and observed as follows:-

1. Unit has provided ETP of capacity 2.0 CMD for the treatment of effluent generated from washing activity and leakage testing activity and it is of lesser capacity.
2. Unit has submitted the B.G of Rs 50,000 and Rs 1.0 lakhs which is expired on 31.03.2023.
3. There are 2 Nos of shot blasting and 1 No of dry zinc system which is not mentioned in the consent.


4. Unit has provided water curtains instead of fabric bag filter to paint booths and the operation and maintenance of water curtains found in poor conditions.

**AND WHEREAS** it has been observed that you have failed to comply with the conditions stipulated in the combined Consent and Authorization (CCA) granted by the Board and thereby creating the smell nuisance into the environment and nearby area and thereby causing air pollution into the environment.

**NOW THEREFORE**, in view of the above non-compliance, you are hereby directed to show cause as to:

1. Why your consent shall not be refused?
2. Why your industrial activities shall not be closed down ?
3. Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit ?

You are hereby called upon for personnel hearing **on 26.09.2024 at 4.00 p.m** before undersigned at above address, failing which, MPCB will initiate legal action against your unit without giving any further notice in accordance with the provisions of the Air (Prevention & Control of Pollution) Act, 1981, which please note.
