With reference to the above, the personal hearing extended on 26/08/2024. Considering your submissions during the hearing and Report of Sub Regional Officer Satara. The Board has decided to issue following interim directions,

- (1) You shall not carried out any activities before grant of consent to operate from the Board.
- (2) You shall obtain membership of CHWTSDF within 60 days.
- (3) You shall mentain a record of HW generation and its disposal as per the Hazardous and Other Wastes (M & TM) Rules, 2016.
- (4) You shall not carry out washing activity and any other trade effluent generating activities till to provision of effluent treatment plant with adequate capacity to treat trade effluent so as to achieve effluent discharging standards.
- (5) You shall submit the fresh Bank Guarantee of Rs.25,000/- (Twenty Five Thousand Only) towards compliance of above directions. The Bank guarantee shall submit within 15 days in faver of Regional Officer, MPC Board, Pune.

You shall submit action taken report on above directions within 15 days, in case you fail to comply with the above directions the Board will have no option to initiate further legal action as deemed fit, which may please be noted.
