WHEREAS, the Maharashtra Pollution Control Board has granted you Combined Consent under the provisions of the Water (P&CP) Act, 1974 and the Air (P&CP) Act, 1981 and Authorization under the provisions of the Hazardous & Other Wastes (Management & Trans boundary Movement) Rules, 2016, subject to certain terms & conditions.


AND WHEREAS, it was obligatory on your part to provide adequate and suitable pollution treatment & disposal arrangements, so as to achieve the standards prescribed in the consent and to dispose of it in accordance with the condition laid down for disposal in the consent.

AND WHEREAS, this office has received proposal from Sub-Regional Office, MPCB, Kalyan -1 in which they have reported that soap solution effluent from process is mixing to adjoin nallah.

NOW THEREFORE, in view of the above non-compliances, you are hereby directed to show cause as to:

- 1) Why your consent shall not be revoke?
- 2) Why your manufacturing activity shall not be stopped until you take remedial measures in respect of above non-compliances?

Your reply shall reach this office within period of 03 days from date of receipt of this direction, failing which, the Board will have no option then to initiate appropriate legal action against you, which please note. Also, you are instructed to present for **personal hearing on 26/05/2022 at 11.45 a.m.** along with your submission and necessary documents.
