WHEREAS, the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under Rule 6 of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016, on 01/11/2022, which is valid upto 31/12/2028 subject to certain terms and conditions.

AND WHEREAS, it was also obligatory on your part to provide adequate and efficient pollution control devices and take adequate measures to control air & water pollution, so as to achieve the consented standards.

AND WHEREAS, Board officials visited your site on 24/06/2024 at M/s. Swastik Infra Logics Private Limited, Survey No.59, Part 60, CTS No.738 (Part), Village Nahur, Bhandup "S" Ward, Mumbai- 400078 & reported as under;

- 1. You are operating Ready Mix Concrete Plant for commercial purposes thereby violating consent condition no. 3.
- 2. You are operating Ready Mix Concrete Plant at night time thereby violating consent condition no. 9.
- 3. You are disposing substandard effluent i.e. cement slurry outside your premises through hose pipes.

AND WHEREAS, Board has issued interim direction on 01/12/2023, thereafter, Board has given reasonable & sufficient time to provide and operate pollution control system effectively.

AND WHEREAS, it has been observed that you have failed to comply with the consent conditions and to provide adequate pollution control devices and thereby contributing to deterioration of ambient air quality of nearby area.

NOW THEREFORE, in view of the above non-compliances, you are hereby directed to stop your manufacturing activities forthwith, failing which, the Board will have no option than to initiate appropriate legal action under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981.
