WHEREAS, Ministry of Environment, Forest & Climate Change, Govt. of India has notifies, Water(Prevention and Control of Pollution) Act, 1974 for prevention and control of water pollution and the maintaining or restoring of wholesomeness of water and Air (Prevention and Control of Pollution), Act, 1981 for prevention, control of air pollution.

AND WHEREAS, it is mandatory and obligatory on your part to abide the provisions made under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Hazardous & Other Waste (Management & Tran boundary Movement) Rules, 2016 for running your industrial activity at aforesaid location.

AND WHEREAS, it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions so as to achieve the standards prescribed by the Board in its consent.

AND WHEREAS, Board officials of SRO – Nashik visited your industry on 26.02.2024 for checking the compliance of consent condition and observed following non – compliance: -

- 1. You are operating your unit without Consent from the board.
- Necessary Sewage treatment plant is not provided.
- The said hotel is located in Vicinity of Gangapur dam which is basic source of Nashik City & River Godavari (notified River).
- 4. Organic waste Composting not provided.
- 5. Using the one open well & one bore well without CGWA NOC.
- Waste water from swimming pool & backwash is use directly for gardening without any treatment.

AND WHEREAS, the above non-compliances amount to serious violations and clearly shows your gross negligent attitude towards pollution control.

AND WHEREAS, it seems that, your unit is habitual defaulter, and you are knowingly and willingly causing the grave injury to the Environment in the nearby area.

NOW THEREFORE, in view of the above non-compliance, you are hereby directed to show cause as to:

- 1. Why your consent shall not be revoked?
- 2. Why your industrial activities shall not be closed down?
- 3. Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit?

You shall remain present at this Office for personal hearing on 12.06.2024 at 12:30 P.M. along with yours say and present status of your unit with relevant documents failing which the Board will be constrained to issue appropriate final Directions as deemed fit in your case, which may please be noted.
