**Sub:-** Closure Directions under section 33A of the Water (P&CP) Act, 1974 & under section 31A of the Air (P&CP) Act, 1981 and Hazardous & Other Wastes (M&TM) Rules, 2016.

**WHEREAS**, you are operating your industry in Water & Air pollution prevention area declared under Water (P&CP) Act, 1974 Air (P&CP) Act, 1981. AND WHEREAS, Board has granted consent to your industry subject to certain terms & conditions therein. AND WHEREAS, it is obligatory on your part to comply those conditions and provide necessary water & air pollution control devices and operate them continuously and efficiently so as to meet the standards prescribed by the Board at all times.

**AND WHEREAS**, Board has issued Show Cause Notice for closure on dtd. 17/01/2023 based on non-compliances reported by officials SRO Tarapur-I during their visited on dtd. 16/01/2023 as,

- 1) You are discharging substandard effluent into CETP i.e. TDS-3100 mg/l.
- 2) The SCADA system is not functioning properly as noted during visit.
- 3) You have not provided wet scrubbers to 2-Nos. of 4-TPH & 8-TPH capacity coal-fired boilers as per consent conditions.
- 4) JVS analysis reports dtd. 11.08.2022 and dtd. 12.12.2022 found exceeding the consented limits for parameter TDS.

**AND WHEREAS**, You have submitted/uploaded reply against Show Cause Notice issued vide dtd. 19/01/2023 which is found unsatisfactory.

**AND WHEREAS**, after examining all the reports and records available with this office, I have come to the conclusion that you are knowingly and willfully violating the consent conditions under the provisions of Water (P & CP) Act, 1974 and Air (P & CP) Act, 1981.


**AND NOW THEREFORE**, in the exercise of the powers conferred u/s 33A of Water (Prevention & Control of Pollution) Act 1974, and 31A of Air (Prevention & Control of Pollution) Act, 1981. I, Regional Officer, MPCB, Thane hereby directed to close down your manufacturing activities, within 72-hours taking all precautionary measures for safe closure, It shall be noted that competent authorities are hereby directed to disconnect your electricity and water supply.
