As a principle of natural justice, a personal hearing was extended to you on 09.11.2020. During personal Hearing, issues related with pollution problems of your industry were discussed in detail. Considering your assurances to improve Environment in your industry, following Interim directions are issued under Section 33A of the Water (P & CP) Act, 1974 & 31A of the Air (P&CP) Act, 1981 for compliance.

- 1. Industry shall comply consent condition, R.M.C. guidelines regularly to achieve the standards.
- 2. Industry shall provide dust control enclosures to mixing section, and fixed type water sprinkling arrangement for the dust suppression due to vehicular movement.
- 3. Industry shall provide soak pit for the disposal of domestic effluent.
- 4. Industry shall submit the compliance of above mention points within 15 days to this office.

In case, you fail to comply with the above Directions, the Board will hav no option than to forfeit the Bank Guarantee and issue final directions as deemed fit in your case, along with suitable legal action which may please be noted.
