WHEREAS, the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981 is applicable to the State of Maharashtra as declared in official gazette. AND WHEREAS, the area where your activity is situated, falls under the said declared area.

**AND WHEREAS**, Board has granted Consent to Operate your unit with the certain terms & conditions & obligatory on your part to comply with the same.

AND WHEREAS, it was obligatory on your part to provide adequate and suitable pollution control equipment and take adequate measure to control air & water pollution from all sources, it was also obligatory on your part to operate & maintain pollution control devices & avoid nuisance to surrounding area.

AND WHEREAS, complaints regarding causing pollution nuisance due to your industry.

AND WHEREAS, to investigate complaint board official of SRO Mahad visited to your unit on 08.04.2021 & reported following non-compliances:

- The Incident of leakages occurred in calcium chloride containing tank of your industry and it was percolated in the open plot at back side of your industry towards the north direction through compound wall
- 2. Also solid waste found in burnt condition inside factory premises.
- A tank containing FBA (Fluoboric Acid) (qty. approximately 4.0 ton) in front of office near main gate also got leaked and chemical found flown/spread inside the

factory premises. Approx. 2.0 ton was recovered, but rest of it was mixed with MIDC nalla.

- 4. Chemical effluent which was spread at many places inside factory premises observed in dry condition.
- 5. Overall housekeeping of your industry is very poor.

AND WHEREAS, after examining all the reports and records available with this office, I have come to the conclusion that you are knowingly and willfully violating the provisions of Water (P & CP) Act, 1974 Air (P & CP) Act, 1981 and Hazardous Waste (Management, Handling & Transboundary Movement) Rule 2016.

**NOW THEREFORE,** in exercise of the power confirmed by the Board upon me u/s 33A of the Water (Prevention & Control of Pollution) Act, 1974 & u/s 31A of the Air (Prevention & Control of Pollution) Act, 1981 following proposed direction are issued against your unit as to

1. Why your existing activity/unit shall not be closed down?.

Why the competent authorities shall not be directed to disconnect water & Electricity supply for closing down manufacturing activity?.

3. Why legal action shall not be initiated against you?.

Your reply / objections if any shall be submitted within 7days from the receipt of this notice, failing which the Board will issue above directions as may deem fit in your case which may please be noted.
