Sub: Direction u/s 33A of the Water (Prevention & Control of Pollution) Act, 1974 , u/s 31 A of the Air (Prevention & Control of Pollution) Act, 1981 to stop construction of STP on land at Reservation No. 1/130 at Chikhali, Tal. Haveli, Dist. Pune.

WHEREAS, your construction of STP is located in the "Pollution Prevention Area" under the Water Act, 1974; under the Air Act, 1981 and Authorization under the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 and amendments therein from time to time.

ANDWHEREAS, it is obligatory on your part to obtain Consent to Establish of the Board for your STP prior to start of installation work & it is obligatory on your part to provide pollution control system as it warranted and to operate and maintain the same continuously and effectively for prevention and control of pollution.

ANDWHEREAS, you have not obtained consent to Establish for construction of STP at Chikhali from Board office.

ANDWHEREAS, during the visit of Committee constituted by the Hon'ble NGT, it is observed that, you have started construction of STP at Chikhali without obtaining consent to Establish from the Board.


ANDWHEREAS, There is a complaint against the PCMC regarding location of this STP in the NGT vide reference at Sr.No.1.

NOW THEREFORE, in exercise of powers conferred upon me by the Board u/s 33A of the Water (Prevention & Control of Pollution) Act, 1974 and u/s 31 A of the Air
